Information Sheet

Here's what you need to know about filing your assessment appeal with the Kettle & Stony Point Assessment Review Board (ARB)

Step 1 – Know your filing deadline

- a. Check your Real Property Assessment Notice for the mailing date.
- b. You may file a Request for Reconsideration (RfR) with MPAC OR you may file an appeal directly with the ARB.
- c. Your deadline to file an RfR is **30 days** from the **mailing date** of your Real Property Assessment Notice.
- d. If you file an RfR and do not agree with MPAC's decision you may still file an appeal with the ARB.
- e. Your deadline to file with the ARB is **90 days** from the **mailing date** of your Real Property Assessment Notice, regardless of whether you choose to first follow the RfR process.

Step 2 – Know how to file

You can fill out appeal forms available:

- At the Band Administration Office

Step 3 - Know how to send us your appeal form

Step 4 - Know what happens next

- You will receive an acknowledgement letter from the ARB once your appeal is received.
- Notice of your hearing will be sent to you before the hearing date telling you the date, place and time of your hearing.

^{*}Note: MPAC's process is free. The ARB requires a filing fee of thirty dollars (CDN \$30).

Frequently asked questions

What does MPAC do?

MPAC assesses and classifies properties in Ontario. It prepares and mails out real property assessment notices. If you have any questions about your assessment notice or believe your assessment is wrong please **contact MPAC first.** MPAC is a completely different organization than the ARB. Contact MPAC at 1-866-296-6722 to find out more about their process.

What's the cost for filing an ARB appeal?

Thirty dollars (CDN \$30) payable to Chippewas of Kettle & Stony Point. Cheques are preferred. If alternate payment arrangements are required, please contact the Band Administration Office for assistance.

Can I get a refund of the filing fee?

There are no refunds of the filing fee.

Can the ARB lower my property taxes?

If the ARB changes your assessment, the Band should update your taxes. The Band is responsible for setting your tax rate. Contact the Band with questions about your property taxes.

Can I file an appeal even if my assessment is the same as last year's?

You can file an appeal for this taxation year as long as it is before the deadline.

What is the deadline to file my appeal?

The deadline to file your appeal should be on your notice from MPAC or on the response from MPAC on your RFR. If you are unsure of the deadline, please contact the Band Administration Office at (519) 786-2125.

Are the hearing venues accessible?
