



## **CHIPPEWAS OF KETTLE & STONY POINT BAND MEMBERS** **DISTRIBUTION 2023**



The Chief and Council of the Chippewas of Kettle and Stony Point First Nation has approved a Clench Distribution for Band Members (**MUST HAVE REGISTERED STATUS AND BAND MEMBERSHIP**) who are on the Band List as of October 30, 2023.

Band Members 18 years of age and older will receive \$750.00 and for Band Members 17 years of age and under will receive \$250.00 by CHEQUE or EFT, if applied for by the parent(s)/guardian(s), with the remaining \$500.00 going into Trust.

After these distribution dates, cheques can then be picked up at the Administration Office/Finance Department during regular office hours by appointment, 8:30AM to 4:30PM; Or you can, by fax or email, send a written request along with your address and copy of ID to have the cheque mailed out.

*\*Any cheques that have been requested to be mailed out will start on November 27, 2023.*

**DEADLINE FOR COMPLETED DEPENDENT REGISTRATION FORMS IS ON:**

**TUESDAY, NOVEMBER 14, 2023 - To receive payment during November 17th-23rd!**

**WEDNESDAY, NOVEMBER 15, 2023 AND ONWARD will be processed afterwards**

**(Starting November 27, 2023).**

*\*Parent(s) or Guardian(s) who do not submit for their Dependents before March 31, 2024 will have the full \$750.00 transferred to the Dependents Trust Account.*

**EFT (Direct Deposit) for anyone 18 year of age and Older**

**No application forms are required. Payments are processed from the names on the Band List.**

If you have in the past, received funds through Electronic Funds Transfer (EFT) to your bank account, then the Distribution dollars will be deposited into your account and no other action is required.

**IF YOUR BANK ACCOUNT INFORMATION HAS CHANGED**, please notify the finance office with your new banking information, otherwise the funds will be directly deposited into the banking information that the finance office already has on record – please use the EFT Form to change your banking information.

**IF YOU HAVE NEVER RECEIVED DIRECT DEPOSIT OF FUNDS IN THE PAST AND YOU WISH TO SIGN UP FOR EFT**, please use the EFT Form to sign up.

YOU CAN FAX, EMAIL OR DROP-OFF YOUR EFT FORM TO THE ADMINISTRATION OFFICE.

**IMPORTANT**: Include with your EFT Form, a clear copy of your ID in order for it to be accepted (ID may be status card, drivers' licence, health card, birth certificate).

**17 Years & Under**

**Anyone with dependents 17 years & under must fill out a DEPENDENTS FORM**

**\*Members turning 18 yrs of age during November 17<sup>th</sup> to 23<sup>rd</sup>, 2023 will receive their own DISTRIBUTION\***

*\*Members turning 18 that wish to have direct deposit, must complete the EFT Form as per the above instructions. Please note that the Bank Account must be in their name only. \**

Blank Dependent forms will be available at the Administration Building (Located at 6247 Indian Lane) or on the Kettle Point Website ([www.kettlepoint.org](http://www.kettlepoint.org)).

**Instructions:**

- Complete the Dependents Form.
- Attach a copy of the children(s) ID (status card, health card, birth certificate, photo card)
- Include a copy of the parent(s)/guardian(s) ID.

If you are a parent or guardian who is NOT a member of the Kettle & Stony Point FN, you may still apply for your child. **HOWEVER, YOU MUST** have the other parent (who is a member) sign the form as well **or** include your proof of custody.

If you are a guardian of the child, then you must include a copy of your proof of custody, along with the child's and your ID.
